The Provincial Council of Granada is a supralocal and intermediate government with the recognized constitutional right to manage, with complete autonomy, the specific interests of the province of Granada.

The Provincial Council of Granada, in its status as a local public entity and assisting body to 172 municipalities, carries out a policy supporting balanced and sustainable development in the province, promoting, with this common aim, measures and actions in the most diverse fields: provincial development, equal opportunities and youth, culture and heritage, tourism, environment and renewable energies, social well-being, works, etc.

**PROJECT OBJECTIVES**

The overall objective of this project focuses on removing roles, stereotypes and sexist references that build gender socialization of young people of school age, in order to know, how the transmission of these roles determines their professional and occupational expectations, in order to establish a more diverse and egalitarian labor market.

Specific objectives:

- Identify gender bias in educational and vocational guidance practices currently operating in young school age. Train the entire educational community (students, teachers, families ...) for the detection and correction of academic segregation (explicit curriculum) and hidden curriculum; and generate an educational project that leverages the full potential of students without gender restricting.
- Raise awareness among social partners about the discriminatory impact of occupational segregation in the labor market, and the benefits of the gender diversification in professional fields. Generate real commitments for change in companies and agents with competence in the labor market.
- Exchanging new methodologies between entities operating in the European public sector (local and regional level), either in research and / or social intervention (gender perspective).

**ACTIVITIES FUNDING  
UNDER THE CALL**

- Round tables discussion and sharing of information of projects already made, and ex – ante assessment of curriculum and labor content in relation to gender and equal opportunities.
- Training activities, creation of technological tools and educational materials on gender and equal opportunities to different stakeholders. Creating an innovative methodological process, in order to revert traditional learning models. It will be susceptible to be transferred to other European realities.
- Meetings, conferences and seminars of good practices exchange. Commitments in vocational diversification in Europe.
